It is with pleasure and conviction that I offer this letter of support for Kickstand's application to the My interactions with the Kickstand team have largely been connected to my work as the Director of the National Center for Homeless Education (NCHE). I have been involved in education at all levels for more than 25 years and have a genuine appreciation for partners and colleagues who work on behalf of those who provide direct student services. Kickstand clearly benefits the efforts of both State Coordinators of Homeless Education and local liaisons in each of the school districts their model supports. In particular, there are four areas that I would like to address in speaking to the quality of their application:

The training portal that Kickstand provides allows those who undertake this commitment at the local/community level to equip themselves with the tools and knowledge necessary to turn the ______ commitment into a permanent reality.
- <u>Communication</u> The staff at Kickstand have been nothing but supportive, collaborative, and
 responsive. The trainings provided cover a wide range of topics, just as the students and
 professionals we serve in our field have a wide range of needs. I have seen first-hand the skillful,
 respectful, professional ways the organization embarks on its work and this results in better
 services for the children and youth we support.
- Partnerships Kickstand has been a valuable partner in leading the field of homeless education toward greater capacity to support our students. Kickstand has participated in our Annual State Coordinators meetings and in the National Association for the Education for Homeless Children and Youth annual conferences for several years.
- Long-term sustainability It is clear that Kickstand is in an ideal position to take the next step. Strong relationships exist and there is now a demonstrated track record of effective communication and success in states across the country. NCHE has served as the U.S. Department of Education's technical assistance center for the Education for Homeless Children and Youth (EHCY) program for more than 20 years. I am writing to offer my strongest support for the application for funding submitted by Kickstand.

I have had the pleasure of working with Kickstand for the past three years – first in my capacity as Director of Policy and Programs at the National Association for the Education of Homeless Children and Youth, and now as Executive Director of SchoolHouse Connection. SchoolHouse Connection is a national organization working to overcome homelessness through education. We provide strategic advocacy and technical assistance in partnership with early childhood programs, schools, institutions of higher education, service providers, families, and youth.

The educational needs of homeless children and youth are great, and so too are those who are charged with removing barriers to their school identification, enrollment, attendance, and success. Without comprehensive and effective training that allows professionals to demonstrate mastery of content, the federal law that supports the education of homeless children and youth will not be implemented. The end result will be children and youth who fail to reach their full potential, and who remain at risk of continued homelessness as adults.

Earlier this year, I witnessed the transformative power of the Kickstand homeless education platform at a meeting of state coordinators for the education of homeless children and youth. State coordinators spoke of the profound changes in practice that resulted from the Kickstand platform - the increased identification and support for children, youth, and families. The Kickstand staff demonstrated a strong ability to work alongside these professionals, listen to them, reflect feedback, and modify the modules accordingly. Kickstand clearly values partnerships, and knows how to create, sustain, and build them over time.

The early successes of the Kickstand platform, combined with the responsiveness of the Kickstand staff, indicate a high degree of sustainability. Kickstand has shown that it can modify and adapt to changing circumstances, all while keeping the focus and integrity of their work. For these reasons, we support expansion through dedicated funding. On behalf of the National Law Center on Homelessness & Poverty (the Law Center), I'm pleased to submit this letter of support for Kickstand's proposal to the to establish a liaision credentialing program that would strengthen education rights for homeless children and youth.

The Law Center is the only national organization dedicated solely to using the power of the law to prevent and end homelessness. Founded in 1989, we envision an end to homelessness in America, where a home for every family and individual will be the norm and not the exception—a right and not a privilege.

Kickstand's proposal for a liaison credentialing program would complement the Law Center's efforts to assist state coordinators and homeless liaisons across the country in implementing Every Student Succeeds Act (ESSA) and the McKinney-Vento Homeless Assistance Act. In partnership, we will develop professional development and training materials for liaisons, school district legal counsel, and other school personnel to improve compliance with ESSA and McKinney-Vento, and work with the state to collect data for further advocacy.
